GOLF OUTING CONTRACT

Dear _____,

Thank you for your interest in holding a golf outing at our facility. Please read the following:

1. Whitetail is a non-metal spike facility. Be sure to tell all your players.
2. To hold an outing at our course from May 1st to October 1st, you must utilize one of our food and beverage packages listed in our outing rate sheet, combined with our golf outings rate package. In _____ from the time frame listed, we will not accept any outing that does not combine golf and a food and beverage package. If a group/outing chooses not to purchase a food package, they will be required to pay a fee of \$3.00 per person.
3. All monies paid to the Whitetail Golf Club for golf, must be paid by the chairperson running the event prior to teeing off. Outings may not let players pay individually. **Please bring separate checks for both golf and food and beverage.** You may not pay for golf and food and beverage on one check.
4. ITEM #6 ON CONTRACT: 8 DAYS PRIOR TO YOUR EVENT, YOU AS THE CHAIRPERSON, MUST CALL THE HEAD PROFESSIONAL AND FOOD AND BEVERAGE MANAGER WITH A FINAL COUNT OF PLAYERS. YOU WILL THEN BE HELD RESPONSIBLE TO PAY FOR THAT NUMBER OF PLAYERS GIVEN 8 DAYS PRIOR, EVEN IF YOU LOSE PLAYERS BEFORE DAY OF EVENT.

Please read your contract, (UNDERSTAND ITEM #6), when you are ready to secure your date you must; fill out both the food & beverage contract and course worksheet and sign where needed, make copies for your records, mail back the contract and worksheet provided, along with deposit check to address listed. GROUP REGISTRATION

Thank you for your interest in Whitetail for your group event. The following regulations and rate schedules apply to all approved outings at Whitetail Golf Club. A contract is enclosed, please verify any information we have entered, fill out the remainder, and return it to us with your deposit as soon as possible (60 days before event). We at Whitetail are dedicated to making your event as enjoyable as possible. Please let us know if you have any questions or comments.

1. Outside groups of more than 20 players require advance registration, and are subject to a deposit based on group size. An outing is officially registered when the deposit is received and a signed contract is returned. Refer to the Group Rate schedule for rates and deposit requirements.
2. Professional services are available for groups of all sizes, and prices are not included in the group rate.
Services available:

Professional Scoring	\$2.00 per player
Calloway Scoring	\$2.50 per player
Professional Instruction	See Enclosure
3. The nature and amount of prizes and/or food and beverage will vary, however, all food and beverages must be obtained through Whitetail. No food and beverages may be brought onto Whitetail's property.
4. Shotgun events: *CALL PRO SHOP FOR DETAILS*
5. Deposits are required for all outings. Deposit amounts are based on estimated group size with up to a maximum of \$750.00, and all are due at least 60 days in advance of the event. Once the signed contract is returned along with the deposit, the outing date is considered secured. The amount deposited will be applied to your final charge.



6. All outings must confirm their player counts at least 2 weeks in advance. 8 days prior to event, we will expect calls to the head professional and restaurant manager with the final count, which you will be held to pay for that number of players. Final billing charges are based on confirmed counts given 8 days prior to event.

7. Groups must cancel at least 3 weeks prior to the event, in order to receive their full deposit refund. All outings are considered playable as scheduled, unless the course is closed due to weather, at which time you will receive your deposit back. Note: Whitetail is the sole judge as to whether the golf course is playable.

8. Each outing sponsor is responsible for making players aware of Whitetail's rules and regulations. These are included in your outing material.

9. Golf charges are final and due and payable BEFORE TEEING OFF.

10. Groups of more than 20 players require outing deposit, secured by check;

20 to 28 players	\$200.00 deposit
28 to 52 players	\$500.00 deposit
52 or more	\$750.00 deposit

11. All outing prices include riding cart. Players may walk, but they still will be charged for a cart.



WHITETAIL GROUP RULES AND REGULATIONS

*******SLOW PLAY WILL NOT BE TOLERATED*******

If you have players that are novices, please make them and all players aware that they are to keep pace with the group in front of them at all times. Player Assistants will warn a group if they fall behind one hole, that they must pick up their pace, 2nd warning will result in making group pick up ball and advance to the next tee. 3rd warning will result group being pulled from the course without refund. Sorry to say that most slow play is resulted from outings, usually from having players who are not aware of slow play. You as chairperson, are responsible to warn all players about our policies! Therefore, please do not be surprised when we take action.

**** NO SCORE MORE THAN DOUBLE PAR ****

Whitetail's "Top 7" Please make all players aware of the accompanying rules. All outing sponsors are responsible for their player behavior.

1. Dress policy: collared shirts, no tee shirts or tank tops, golf shorts only, no cut offs, swim or gym shorts allowed.
2. No alcoholic beverages, coolers or food permitted on course property, unless purchased through Whitetail.
3. All players must report to the starter at least 10 minutes prior to their scheduled tee time, or 30 minutes for a shotgun start.
4. Golf cart rules change due to daily weather conditions and time of year, cart policies for each day will be listed at the pro shop. Obey daily cart rules.
5. Pace of play is vital to our operation. All groups are expected to play in 4-1/2 hours, and to keep up with the group in front of you. A Players Assistant will be on duty, and has full authority to enforce regulations and pace of play.
6. Practice course etiquette. Repair ball marks, replace divots, and rake all bunkers. Leave the course in the condition you found it, as a courtesy to the next player.
7. Additional rules and regulations are listed at the Whitetail Golf Club. Any matters not covered in this section are subject to the decision of the Whitetail Management.
